

Fund description and summary of investment policy

The Fund invests in South African money market instruments with a term shorter than 13 months. These instruments can be issued by government, parastatals, corporates and banks. The Fund is managed to comply with regulations governing retirement funds.

While capital losses are unlikely, they can occur if, for example, one of the issuers of an instrument held by the Fund defaults. In this event losses will be borne by the Fund and its investors.

ASISA unit trust category: South African – Interest Bearing – Money Market

Fund objective and benchmark

The Fund aims to preserve capital, maintain liquidity and generate a sound level of income. The Fund's benchmark is the Alexander Forbes Short Term Fixed Interest (STeFI) Composite Index.

How we aim to achieve the Fund's objective

The Fund invests in selected money market instruments providing an income yield and a high degree of capital stability. We formulate an interest rate outlook, which is influenced by our inflation outlook and expectations of the resulting Reserve Bank policy response. Based on this analysis, we select investments for the Fund. These assets are typically held to maturity. We take a conservative approach to credit risk.

Suitable for those investors who

- Require monthly income distributions
- Are highly risk-averse but seek returns higher than bank deposits
- Need a short-term investment account

Annual management fee

A fixed fee of 0.25% p.a. excl. VAT

Total expense ratio (TER) and Transaction costs

The annual management fee is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

In these everchanging times, what a difference just one quarter can make. We have seen the South African Reserve Bank lower interest rates by a further 1.5% to the current repo rate of 3.75%. We have watched South Africa's main budget deficit, or the difference between our national revenue and national costs, more than double in estimate from -6.8% of GDP to -14.6% of GDP. Put differently, in the current fiscal year government is likely to over-spend by an amount of R709bn.

Our National Treasury warns that we are headed into a "debt spiral", with government debt threatening to consume 87% of our economy (as measured by GDP) in the next three years. Practically, we know that it is not possible to continuously borrow one's way out of debt. Additionally, such a burden will mean that out of every rand that a taxpayer parts with, 22 cents will go towards paying off interest on old debt. Taken alone, such a statement sounds alarming, but what sits at the heart of this calamity is that these 22 cents cannot go towards infrastructure, employment creation, social grants or education.

Finance Minister Tito Mboweni looks ahead and proclaims: "Our Herculean task is to close the mouth of the hippopotamus!" We support his sentiments that conservatism is needed and concur that wasteful spending must be eliminated. Conservatism is an interesting concept, and one which informs our approach to investing in the Fund. We aim to maintain capital protection and do so by

investing in a mix of government treasury bills, South African bank deposits, and the short-term debt of highly rated corporates. Our approach to investing has not changed, but our expectations of future money market returns have. Naturally, these expectations are lower in line with those of national interest rates.

The most popular question I have received lately is "How quickly will yields in the Fund fall?". This is unsurprisingly impossible to predict given that both maturing paper and new cash inflows in the Fund must be invested at current (lower) market rates. With South Africa's latest inflation print at 3% and inflation expected to fall further given the COVID-19 economic slowdown, we are confident that we can deliver returns in excess of inflation in the near term. That said, we foresee a time approaching when the reappearance of inflation, coupled with low short-term rates, should mean that money market investments will struggle to protect real "inflation-adjusted" wealth.

In the last quarter, we have found opportunities to invest in the debt of strong companies at slightly elevated spreads – around 1.5% to 2% higher than short-term bank interest rates.

Management Company

Allan Gray Unit Trust Management (RF) Proprietary Limited (the 'Management Company') is registered as a management company under the Collective Investment Schemes Control Act 45 of 2002, in terms of which it operates 11 unit trust portfolios under the Allan Gray Unit Trust Scheme, and is supervised by the Financial Sector Conduct Authority ('FSCA'). The Management Company is incorporated under the laws of South Africa and has been approved by the regulatory authority of Botswana to market its unit trusts in Botswana, however it is not supervised or licensed in Botswana. Allan Gray Proprietary Limited (the 'Investment Manager'), an authorised financial services provider, is the appointed Investment Manager of the Management Company and is a member of the Association for Savings & Investment South Africa ('ASISA'). The trustee/custodian of the Allan Gray Unit Trust Scheme is Rand Merchant Bank, a division of FirstRand Bank Limited. Performance

Collective Investment Schemes in Securities (unit trusts or funds) are generally medium- to long-term investments. The Allan Gray Money Market Fund is not a bank deposit account

The Fund aims to maintain a constant price of 100 cents per unit. The total return an investor receives is made up of interest received and any gain or loss made on instruments held by the Fund. While capital losses are unlikely, they can occur if, for example, one of the issuers of an instrument defaults. In this event investors may lose some of their capital. To maintain a constant price of 100 cents per unit, investors' unit holdings will be reduced to the extent of such losses. The yield is calculated according to ASISA standards. Excessive withdrawals from the Fund may place it under liquidity pressure; if this happens withdrawals may be ring-fenced and managed over a period of time.

Purchase and redemption requests must be received by the Management Company by 14:00 each business day to receive that day's price. Unit trust prices are available daily on www.allangray.co.za

Fees

Permissible deductions may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and trustee fees. A schedule of fees, charges and maximum commissions is available on request from Allan Gray.

Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged), VAT and other expenses like audit and trustee fees. Transaction costs (including brokerage, Securities Transfer Tax [STT], STRATE and Investor Protection Levy and VAT thereon) are shown separately. Transaction costs are a necessary cost in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of financial product, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. As unit trust expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and Transaction costs is shown as the Total investment charge ('TIC').

Compliance with Regulation 28

The Fund is managed to comply with Regulation 28 of the Pension Funds Act. Exposures in excess of the limits will be corrected immediately, except where due to a change in the fair value or characteristic of an asset, e.g. market value fluctuations, in which case they will be corrected within a reasonable time period. The Management Company does not monitor compliance by retirement funds with section 19(4) of the Pension Funds Act (item 6 of Table 1 to Regulation 28).
