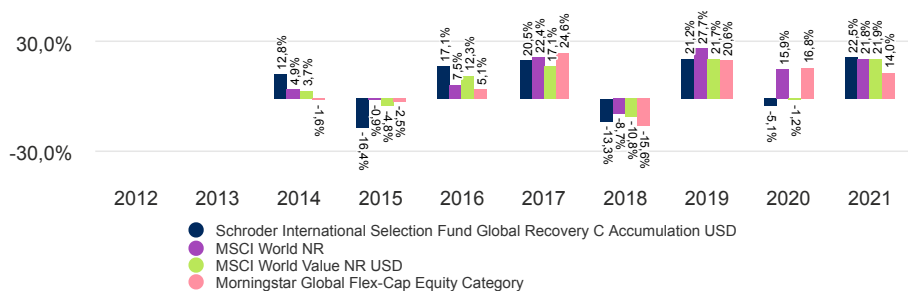

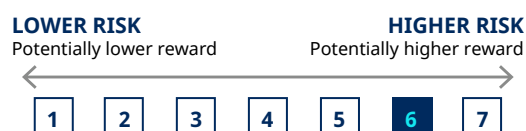

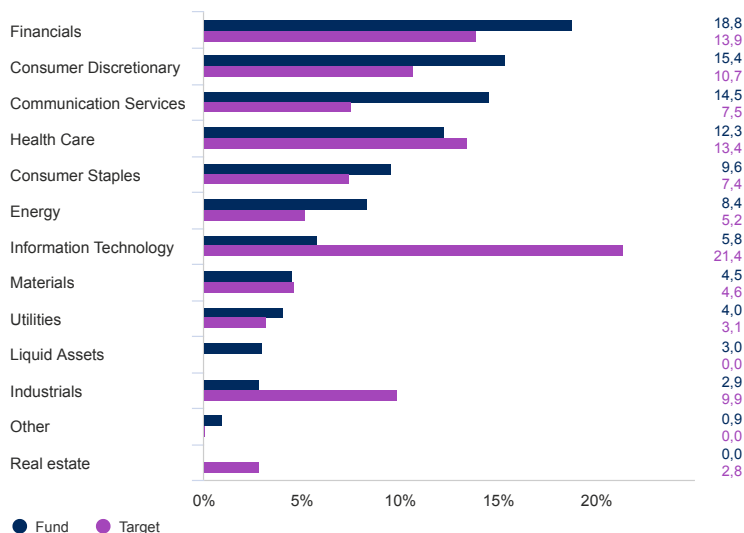

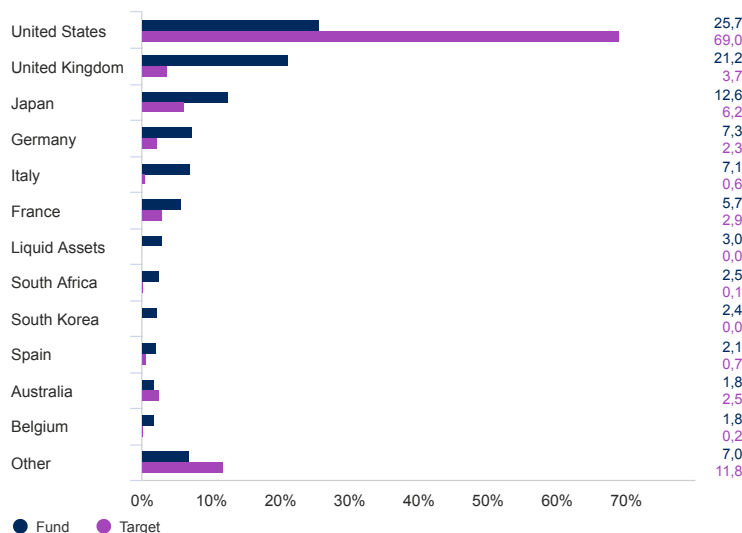

Sector (%)

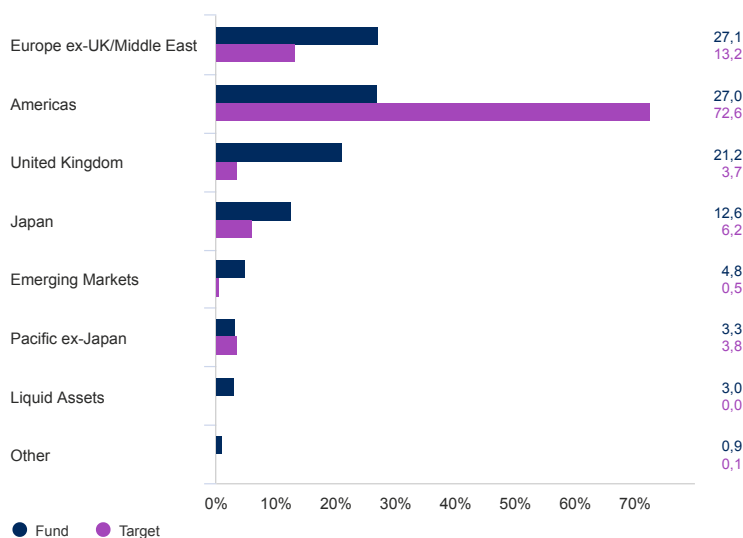


Geographical breakdown (%)
